**2012 ACTION ITEM WATER**

**WATER METER CALIBRATION SERVICES**

**WHEREAS,** The Township of Bloomfield currently pays the City of Newark for wheeling services to provide potable water to the township; and

**WHEREAS,** the Township is billed by Newark on a monthly basis based upon meter readings at the three service locations which are located at Bloomfield Center, at Grove Street and at Garrabrant Avenue; and

**WHEREAS,** it is the recommendation of the Township Engineer and Township Water Operator that these meters be calibrated by an independent vendor to verify their accuracy and proper operation; and

**WHEREAS,** Allied Control Services, Inc., 611 Garfield Avenue, West Point, PA 19486 provided a proposal to perform this work at an amount of \$4,850.00; and


**WHEREAS,** the amount of the contract is under \$17,500.00 and therefore does not require public bid and advertising; and

**WHEREAS,** funding is available for this service within the Township's water capital account No. W-06-55-582-591.

**NOW, THEREFORE, BE IT RESOLVED,** that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and Water Operator and he may enter into a contract for water meter calibration with Allied Control Services, Inc., 611 Garfield Avenue, West Point, PA 19486 in the amount of \$4,850.00.


