**2012 RESOLUTION AWARD OF PROFESSIONAL SERVICE**

**CONTRACT AMENDMENT FOR ADDITIONAL DESIGN & CONSTRUCTION ADMINISTRATION SERVICES – NORTH CENTER STREETScape PROJECT**

**WHEREAS**, the Township of Bloomfield currently has a contract with Arterial, LLC, 105 Grove Street, Suite 11, Montclair, NJ 07042 (the Consultant) for the preparation of design and construction administration services for the North Center Streetscape Project; and

**WHEREAS**, it was the desire of the Mayor and Council to expand the scope of the project and provide additional Capital Funding for this project; and

**WHEREAS**, this approved capital expansion approximately doubled the scope and estimated construction costs thereby requiring additional design services by the consultant; and

**WHEREAS**, Arterial, LLC has provided an amendment to their proposal to provide the required services in the amount of \$16,050.00; and

**WHEREAS**, it is the recommendation of the Township Engineer to amend the current contract in the amount of \$16,050.00 for a new contract price of \$36,280.00 to allow for the additional services; and

**WHEREAS**, funding for the amendment is available in the Township's capital account C-04-55-862-966; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover this cost of this contract amendment.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield authorizes and directs the Township Administrator and/or Township


