2012 RESOLUTION APPROVAL

**TO EXTEND THE GRACE PERIOD FOR PAYMENT OF 2012
4TH QUARTER PROPERTY TAXES**

WHEREAS, due to delays in the postal service from the aftermath of Hurricane Sandy;
and

WHEREAS, the receipts of property tax payments mailed to the township may be
delayed; and

WHEREAS, it is the recommendation of the Township's Director of Finance not to
collect interest on any 4th quarter tax installments paid on or before November 16, 2012.


NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township
of Bloomfield in the County of Essex, State of New Jersey as follows:

TOWNSHIP OF BLOOMFIELD taxes due November 1, 2012 will not be considered
delinquent, and interest for delinquency in the payment of such taxes shall not be charged for
failure to pay any such taxes if received by the Township on or before the 16th day of November,
2012, however, that if any such installment is not paid on or before the 16th day of November,
2012, interest at the usual rate will be charged from November 1, 2012.

BE IT FURTHER RESOLVED, by the Township Council that the actions of the Tax
Collector in waiving said interest as stated above are hereby approved, ratified and confirmed.




