2012 RESOLUTION AWARD OF CONTRACT

PURCHASE OF 2013 AUTOCAD SOFTWARE

WHEREAS, the Bloomfield Engineering Department is in need of updated AutoCAD software to prepare contract bid documents for various capital and CDBG projects; and

WHEREAS, the Bloomfield Information Technology Department obtained a price quote of \$8,586.29 from CDW Government, LLC, 230 N. Milwaukee Avenue, Vernon Hills, Illinois, 60061; and

WHEREAS, CDW Government, LLC, is in possession of N.J. State contract #70262 for this product and can therefore be awarded the purchase without public bid; and

WHEREAS, it is the recommendation of the Township Engineer that the AutoCAD software be purchased from CDW Government, LLC, 230 N. Milwaukee Avenue, Vernon Hills, Illinois, 60061 at a price of \$8,586.29; and

WHEREAS, the Director of Finance has indicated that funding is available within the Township's Community Development Block Grant Program.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into an agreement for the purchase of the above referenced AutoCAD software at a price of \$8,586.29 with CDW Government, LLC, 230 N.
