2012 RESOLUTION CHANGE ORDERS

2012 RESOLUTION – TOWNSHIP GREEN SIDEWALK IMPROVEMENT – CHANGE ORDER NO. 1- FINAL

WHEREAS, the Township of Bloomfield entered into a contract for the Township Green Sidewalk Improvements with Stanziale Construction, PO Box 2597, Bloomfield, New Jersey 07003 (hereinafter “the Contractor”); and

WHEREAS, during the course of construction unforeseen site conditions were encountered which required modifications to the scope of work; and

WHEREAS, the Township Engineer has reviewed the changes enumerated in Change Order No. 1 - Final and recommends the Change Order be approved; and

WHEREAS, Change Order No. 1 - Final represents an increase in the cost of the contract in the amount of \$7,719.53 or 6%; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer, is satisfied that the specified changes should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Director of Finance has certified that the funds are available within Capital Account #C-04-55-850-965.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final, is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
