2012 RESOLUTION ACCEPTANCE

**MAINTENANCE RESPONSIBILITY FOR BUMP OUTS TO BE
INSTALLED ALONG BROAD STREET BETWEEN WAVERLY
PLACE AND HOOVER AVENUE**

WHEREAS, the Mayor and Council of the Township of Bloomfield support the construction of bump-outs as a means of enhancing pedestrian safety and traffic calming as part of its complete streets policy; and

WHEREAS, Broad Street, between Waverly Place and Hoover Avenue, has been determined to be an appropriate street for the installation of bump outs; and

WHEREAS, Broad Street is under the jurisdiction of Essex County; and

WHEREAS, Essex County requires the Township of Bloomfield to assume responsibility for maintenance of the extended curb line as well as snow removal from parking lanes within 100 feet in either direction of a bump out installed on county roads within the Township of Bloomfield.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby agree to maintain the extended curb line and perform snow removal for the bump outs to be installed at Broad Street between Waverly Place and Hoover Avenue as described in the plans prepared by Arterial, Street Design Studio, Sheets L-101, L-102 and L-103 dated August 10, 2012. A copy of the proposed plans are affixed hereto and made part hereof.
