2012 RESOLUTION CHANGE ORDERS

OSI TOWNSHIP PHONE SYSTEM UPGRADE - CHANGE ORDER NO. 1- FINAL

WHEREAS, the Township of Bloomfield entered into a contract for the Township phone system upgrade with Office Solutions, Inc., 217 Mount Horeb Road, Warren New Jersey 07059 for a total contract cost of \$147,770.41; and

WHEREAS, during the course of the project, it was necessary to adjust or modify the amount of items to account for unforeseen site conditions; and

WHEREAS, the Township IT Director has reviewed the changes enumerated in Change Order No. 1 - Final and recommends the Change Order be approved; and

WHEREAS, Change order No. 1- Final represents an increase in the cost of the contract in the amount of \$4,167.31 representing a 2.82% of total cost of the project and

WHEREAS, the Mayor and Council, based on the recommendation of the Township IT Director is satisfied that the specified changes should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Director of Finance has certified that the funds are available within Township Account #C-04-55-819-940 and is reimbursable through a grant from the New Jersey Department of Transportation Trust Fund.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.

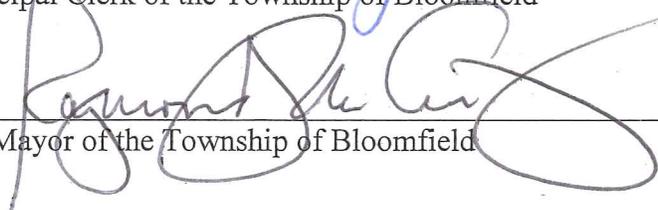
