

2011 RESOLUTION – AWARD OF CONTRACT – UPPER MEMORIAL PARK IMPROVEMENTS

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on January 6, 2011 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A-11-1 et seq., “Local Public Contracts Law” for the Upper Memorial Park Improvements, and

WHEREAS, a total of ten (10) bids were received and were referred to the Township Engineer for review; and

WHEREAS, after review of the bids, the Township Engineer, based upon a recommendation by the project consultant, Birdsall Engineering Services hereby recommends that the contract be awarded to the lowest responsible bidder, D & S Land Development, 13 Alida Place, Ramsey, New Jersey 07446 for the Base Bid plus Alternate A-1 and Alternate Bid Items A-2C, A-2D, A-2E, A-2F, A-2G for a total contract cost of \$467,979.00; and

WHEREAS, the Director of Finance has indicated that funding is available within the Capital Account Numbers C-04-55-989-947; C-04-55-923-947 and C-04-55-810-947; and

WHEREAS, this project is also being funded through a grant and loan from the New Jersey Department of Environmental Protection Green Acres Program.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above improvements to D & S Land Development, 13 Alida Place, Ramsey, New Jersey 07446 for




