**2011 RESOLUTION – ISSUANCE OF A DUPLICATE TAX SALE CERTIFICATES**

**WHEREAS**, P.L. 1997 Chapter 520, requires the authorization of the governing body for replacement and issuance of a duplicate tax sale certificate held by a third-party lien holder which has been destroyed or lost; and

**WHEREAS**, Mohsen B. Razavi has indicated that he was provided with tax sale certificates which have been either lost or destroyed.


**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby authorizes the Tax Collector upon receipt of an appropriate affidavit from the owner of the certificate to prepare a replacement for the following certificate for Tax Sale Certificate #08-00116 and issue to the original lien holder known as Moshen B. Razavi, 91 Hobson Street, Bloomfield, NJ 07003; and




