2011 RESOLUTION AUTHORIZING THE AWARD OF A ONE -YEAR CONTRACT FOR MUNICIPAL BUILDING AIR CONDITIONING SERVICE CONTRACT

WHEREAS, in accordance to N.J.S.A 40A:11-3 a contract may be awarded without public advertisement if the contract amount is under \$21,000.00 in any given contract year; and

WHEREAS, the Township Engineering Department did solicit for prices to perform maintenance and service on the municipal building air conditioner; and

WHEREAS, the Township did receive one proposal from Basic Refrigeration Heating and AC, 414 Broad Street, Bloomfield, New Jersey 07003 for a 1 Year Maintenance Contract at a cost of \$3,520.00; hourly rates are broken down to normal working hours: \$110.00 per hour and emergency working hours are \$165.00 per hour; and

WHEREAS, Basic Refrigeration Heating and AC were found to be qualified to perform this work and their prices were found to be reasonable and competitive by the Township Engineer; and

WHEREAS, the Director of Finance has indicated that funding is available to perform this work in the budget for Municipal Buildings and Grounds Account # 1-01-26-772-024; and


WHEREAS, the proposal documents were reviewed by the Township Engineer and recommended for award.




