**2011 RESOLUTION – INTER-LOCAL AGREEMENT WITH THE BOROUGH OF GLEN RIDGE FOR 2011**

**WHEREAS**, the Borough of Glen Ridge has a need to have their streets swept up to five (5) times a year; and

**WHEREAS**, the Township of Bloomfield has offered to provide street sweeping services to the Borough of Glen Ridge for \$2,000.00 per sweep; and


**WHEREAS**, the Borough Glen Ridge has agreed to allow the Township of Bloomfield Department of Public Works (DPW) to use Glen Ridge’s vehicle wash as needed for the removal of winter salt, dirt, etc. from their vehicles in order to comply with the State mandated Stormwater Management Program.


**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorize the Township Administrator to enter into an agreement with the Borough of Glen Ridge wherein the Township will sweep Glen Ridge’s street up to five (5) times per year at a cost of \$2,000.00 per sweep.

**BE IT FURTHER RESOLVED**, that the Borough of Glen Ridge will allow the Township of Bloomfield DPW to use Glen Ridge’s vehicle wash as needed for the removal of winter salt, dirt, etc.




