2011 RESOLUTION – LEAVE OF ABSENCE

WHEREAS, written application has been filed by Employee # 74875, for a leave of absence with pay, for personal reasons; and

WHEREAS, Employee # 74875 has exhausted all his earned sick leave with the Township of Bloomfield; and


WHEREAS, Dennis A. Tobia, the Township Physician, has certified that Employee # 74875 is unfit to return to work.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Employee # 74875 is hereby granted a leave of absence with pay, from his position for a period of ninety (90) days effective May 20, 2011, provided, however, that the leave is conditioned upon the following:

1. During said leave of absence, Employee # 74875 will not accrue sick leave, vacation leave, personal leave, holiday time coming, holiday pay and uniform allowance, in accordance with the terms and conditions of the Collective Bargaining Agreement that controls the employees employment.
2. During said leave of absence, employee shall continue to be covered for pension, health benefits, dental plan and prescription drug plan and life insurance in accordance with the terms and conditions of the agreement identified in paragraph 1 above.
3. During said leave of absence, if employee engages in any other gainful employment, his paid leave with the Township shall be automatically terminated.
4. Employee must submit to be examined by the Township Physician, Dennis A. Tobia, prior to his return to duty, who must certify to the Mayor and Council the employee's fitness to return to work.




