2011 RESOLUTION – AWARD OF CONTRACT WATER SYSTEM FITTINGS & SUPPLIES – H.D. SUPPLY WATERWORKS, LTD

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on April 14, 2011 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., “Local Public Contracts Law” for Water System Fittings & Supplies; and

WHEREAS, the bids received were referred to the Township Engineer for review; and

WHEREAS, after review of the bids submitted, the Township Engineer hereby recommends that the contract be awarded to the lowest responsible bidder, H.D. Waterworks, LTD, 61 Gross Avenue, Edison, New Jersey 08837 for the contract items specified as follows:




