2011 RESOLUTION – APPOINTMENT, DEPUTY MUNICIPAL COURT ADMINISTRATOR

WHEREAS, the Township of Bloomfield needs a Deputy Municipal Court Administrator in the Municipal Court to perform all of the duties and responsibilities set forth in the Charter of the Township of Bloomfield, its by-laws, ordinances and laws of the State of New Jersey; and

WHEREAS, the Municipal Court has advertised for this position and the Chief Judge recommends that John B. Clayborne be appointed to the position of Deputy Municipal Court Administrator effective July 11, 2011; and


WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this position.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that John B. Clayborne be and is hereby appointed Deputy Municipal Court Administrator effective July 11, 2011 at step 1 in the salary ordinance of the Township of Bloomfield for that position; and

BE IT FURTHER RESOLVED, that John B. Clayborne recognizes that his appointment is provisional and he must follow all Civil Service Commission requirements and appear on an eligibility list before being considered for permanent appointment by the Mayor and Council; and

BE IT FURTHER RESOLVED, that John B. Clayborne recognizes that if he does not appear on the Civil Service eligibility list he will be removed from his position without being considered for permanent appointment.


