**2011 RESOLUTION – 2008 CAPITAL AND CDBG ROADWAY PROGRAM –
CHANGE ORDER NO. 1 - FINAL**

WHEREAS, the Township of Bloomfield entered into a contract for the 2008 Capital and CDBG Roadway Program with Stanziale Construction (hereinafter “the Contractor”); and

WHEREAS, during the course of construction, unforeseen, site conditions were encountered, which required modifications to the scope of work; and

WHEREAS, the Township Engineer has reviewed the changes enumerated in Change Order No. 1 – Final and recommends the Change Order be approved; and

WHEREAS, Change Order No. 1 - Final represents a decrease in the cost of the contract in the amount of \$27,468.03 or 3.9%; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the specified changes should be approved; and


WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Director of Finance has certified that the funds are available within Capital Account #C-04-55-925-965.






