

**2011 RESOLUTION AWARD OF CONTRACT**

**TREE REMOVAL CONTRACT**

**WHEREAS**, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on November 1, 2011 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for Tree Removal; and

**WHEREAS**, a total of one (1) bid was received and referred to the Township Engineer for review; and

**WHEREAS**, after review of the bid submitted the Township Engineer indicated that the total price bid by the contractor was competitive and reasonable; and

**WHEREAS** the Township Engineer hereby recommends that the contract be awarded to the bidder, Andy-Matt, Inc., 11 Scrub Oaks Road, Mine Hill, New Jersey 07830 at a total cost in the amount of \$30,059.00; and

**WHEREAS**, the Director of Finance has indicated that funding is available under Capital Account No. C-04-55-813-988 for this work.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for tree removal with Andy-Matt, Inc., 11 Scrub Oaks Road, Mine Hill, New Jersey 07830 at a total cost in the amount of \$30,059.00.
