

2011 RESOLUTION APPOINTMENT

PART-TIME TEMPORARY LABORER'S

WHEREAS, the Township of Bloomfield's Department of Works needs to hire additional part-time temporary staff members that will work until the end of the February 12, 2012; and

WHEREAS, the employees will be paid through the New Jersey Department of Labor and Workforce Development and shall not be a burden to the Township budget; and

WHEREAS, Antoine Polite-Debois, Anthony Johnson and Kevin Jenkins recognized and understand that this temporary part-time position will end on February 29, 2012; and

WHEREAS, the Antoine Polite-Debois, Anthony Johnson and Kevin Jenkins will work at the rate of \$16.85/per hour and will not receive health benefits as temporary part-time employees; and

WHEREAS, the Director of Finance has indicated that funding is available for this position subject to the conditions in the attached Department of Labor and Workforce Development Agreement.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby hires Antoine Polite-Debois, Anthony Johnson and Kevin Jenkins as part-time temporary employees starting November 28, 2011 and ending on February 29, 2012 subject to the conditions contained this resolution; and


BE IT FURTHER RESOLVED, that these temporary appointments will automatically terminate on February 29, 2012 without any further action by the Mayor and Council.
