

**2011 RESOLUTION APPOINTMENT**

**PART-TIME FILE CLERK IN THE INSPECTIONS DEPARTMENT**

**WHEREAS**, the Director of Community Development and Inspections has indicated that there is a need for additional help in the Township of Bloomfield Inspections Department; and

**WHEREAS**, the Director has interviewed several people and recommends hiring Patricia Farrell (hereinafter "Employee"); and

**WHEREAS**, the Employee will work part-time at no more than twenty-five (25) hours per week at the rate of \$15.84 per hour and, therefore, will not receive health benefits; and

**WHEREAS**, the Director of Finance has certified that funding is available for this appointment.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorize the Director of Community Development to hire Patricia Farrell as part-time employee at the rate of \$15.84 per hour; and

**BE IT FURTHER RESOLVED**, that this employment is temporary and subject to Civil Service Commission approval; and

**BE IT FURTHER RESOLVED**, that the employee acknowledges and understands that if she is not appointed to a permanent position because the Civil Service Commission certifies a list of eligible candidates and she is not selected from the list for appointment her employment will automatically terminate.
