2021 RESOLUTION AWARD OF PROFESSIONAL SERVICE

RESOLUTION - AWARDING A CONTRACT FOR THE PERFORMANCE OF PRELIMINARY ENGINEERING SERVICES TO TAYLOR, WISEMAN & TAYLOR FOR THE MORRIS CANAL GREENWAY AT WRIGHTS FIELD

WHEREAS, the Township wishes to perform improvements to the Morris Canal Greenway at Wrights Field; and

WHEREAS, the Township has been awarded NJDOT Local Aid and Economic Development Transportation Alternatives Program (TAP) grant funding in the amount of \$430,000 for this project; and

WHEREAS, the Township requires the services of an Engineering Consultant to oversee the Preliminary Engineering phase of this project; and

WHEREAS, one of the unique features of this TAP grant is additional funding will be provided via a Design Assistance Program to cover the consultant's costs if one of the four NJDOT prequalified consultants is selected to oversee this project, so as not to impact the \$430,000 grant total; and

WHEREAS, NJDOT conducted a TA Set-Aside Design Assistance Consultant Selection by evaluating, rating and ranking consultants, and Taylor, Wiseman & Taylor (TWT) was one of the four consultants qualified through this process to perform these services; and

WHEREAS, TWT has submitted a proposal to the Township for completing the Preliminary Engineering (PE) Phase on the above referenced project at a total cost of \$143,187.94; and


WHEREAS, it is the recommendation of the Director of Bloomfield Parks, Recreation & Cultural Affairs, and the Acting Township Administrator that the work be awarded to Taylor, Wiseman & Taylor; and

WHEREAS, the Acting Director of Finance has indicated that funding is available in Township Account Number _____.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorize Taylor, Wiseman & Taylor, 124 Gaither Drive, Suite 150 Mt. Laurel, NJ 08054, to provide the Preliminary Engineering services for the Morris Canal Greenway Phase 3 project at a total cost of \$143,187.94.




