RESOLUTION: AUTHORIZING THE DISCHARGE OF A RESIDENTIAL REHABILITATION PROGRAM MORTGAGE LIEN FOR 211 NORTH 15TH STREET

WHEREAS, the Township's Residential Rehabilitation Program provided funding for home improvement projects to qualified homeowners within the Township of Bloomfield; and

WHEREAS, funding was provided to the homeowner of 211 North 15th Street in 2007 and a mortgage lien was placed on the home as part of the conditions of the agreement; and

WHEREAS, the term of the mortgage has expired and may be discharged.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, and State of New Jersey hereby authorize and direct the Township Administrator, or his designee, to sign any documents that are necessary to discharge the mortgage lien held by the Township of Bloomfield in connection with the 2007 funding for 211 North 15th Street.
