RESOLUTION: AUTHORIZING PUBLIC AUCTION OF MOTOR VEHICLES NO LONGER NEEDED FOR PUBLIC USE

WHEREAS, the Township of Bloomfield is the owner of certain vehicles that are no longer needed for public use; and

WHEREAS, the Township of Bloomfield is authorized to sell at Public Auction personal property no longer needed for public use pursuant N.J.S.A 40A:11-36.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

(1) The sale of the vehicles shall be conducted through GovDeals pursuant to State Contract A-83453/T2581 in accordance with the terms and conditions of the State Contract. The terms and conditions of the agreement entered with GovDeals is available online at govdeals.com and available from the Township of Bloomfield.

(2) The sale will be conducted online, and the address of the auction site is govdeals.com.



(5) The Township reserves the right to accept or reject any bid submitted.


